Behavior/Discipline Plan 2016-2017

*Behaviors are categorized by levels (Level I, Level II, and Level III):

Examples of Level I behaviors/ decisions include but are not limited to the following:

- Horseplay
- Inappropriate Language
- Dress code violation
- Lying, Cheating
- Not Prepared for class
- Disruption, excessive talking
- Chewing Gum
- Food or Drink outside of cafeteria
- Tardy to class (As/If needed for exploratory)
- Technology violation: Off task

*Level I offenses are punishable by the **demerit** system

Examples of Level II behaviors/ decisions include but are not limited to the following:

- Pushing Shoving
- Harassment
- Property Damage
- Abusive Language
- Defiance, disrespect, insubordination, non-compliance
- Technology Violations-Cyberbullying, etc.
- Theft (Level III)

–Any behavior with possible legal ramifications is a Level III behavior and should be summarily reported.

* Level II offenses are punishable by **office referral**

Level I Consequence Procedure:

- After 1 demerit: Verbal redirection and warning
- After 3 demerits: Verbal redirection and phone call to parents
- After 6 demerits: Verbal redirection, phone call, and 30 min before/after school detention or 30 min lunch detention (ISS room)
- After 9+ demerits: Phone call to parents, 1 day ISS, and possible exclusion from certain school sponsored activities

***Demerits reset at the beginning of each 9 weeks**

Rewards:

- After 4.5 weeks: Open seating lunch and/or snack reward.
e.g. Popsicles, candy, etc.
- 4.5 week rewards are based on a predetermined aggregate number of demerits and/or referrals
- After 9 weeks: Pizza and outside time (early Fall, late Spring), movie & popcorn (Winter, early Spring)

-9 week rewards are based on a set number of demerits for the individual student. Students with office referrals will not be eligible for 9 week rewards.

Cell Phone Use: If needed for academic purposes, teachers must provide a time for students to retrieve phones from lockers.

*Specific cell phone policy forthcoming.

Technology Violations

Level I: Off task (*example: email, work for another class, game, etc.*)

Consequence: Demerit

Level II: Inappropriate Content (*example: offensive music or language, violent games, cyberbullying etc.*)

Consequence: Office Referral

Level III: Inappropriate Content (*example: nudity, illegal activity, etc.*)

Consequence: Sent to Officer Gibson, Not Allowed to use computers, legal action
